EXECUTIVE SUMMARY

COUNTY FISCAL LETTER NO. 22/23-49

This letter informs counties and federally recognized tribes of the Fiscal Year 2022-23 Excellence in Family Finding, Engagement, and Support Program General Fund (GF) planning allocation. A total of approximately \$150.7 million GF is available based on the Budget Act of 2022. Of the \$150.7 million budgeted, \$750,000 has been set aside for the Center for Excellence in Family Finding, Engagement, and Support. From the remaining \$150.0 million GF, \$7.5 million is set aside for participating Tribes. The balance of \$142.5 million in one-time funding is available for distribution, as shown in the attachment.

This letter informs counties and participating federally recognized Tribes of the Fiscal Year (FY) 2022-23 Excellence in Family Finding, Engagement, and Support (EFFES) Program General Fund (GF) planning allocation. For the purpose of this letter, "participating Tribes" means those Tribes, consortia of Tribes, or Tribal Organizations that elect to access this funding and that have or will enter a state agreement pursuant to <u>WIC section 10553.1</u> or in accordance with <u>25 U.S.C. 1919</u>. A total of approximately \$150.7 million GF is available based on the Budget Act of 2022. Of the \$150.7 million GF budgeted, \$750,000 has been set aside for the Center for Excellence in Family Finding, Engagement, and Support. From the remaining \$150.0 million GF, \$7.5 million is set aside for participating Tribes. The balance of \$142.5 million in one-time funding is available for distribution to County Welfare Departments (CWDs) and County Probation Departments (CPDs), as shown in the attachment. A separate letter will be released regarding funding for participating Tribes.

Background

The <u>AB 179</u> makes available \$150.0 million GF in one-time funding for specialized permanency work, including culturally responsive, family-centered, and trauma-informed family finding and engagement services. Services shall focus on establishing and maintaining permanent connections for foster children with their relatives and extended family members.

An additional \$750,000 GF in ongoing funding was allocated to create the Center for Excellence in Family Finding, Support, and Engagement to provide culturally appropriate training and technical assistance to county child welfare and probation departments, participating Tribes, and foster care providers to enhance their practices, policies, and efforts for family finding, support, and engagement. Please refer to <u>ACL No. 23-12</u> for additional information regarding the Center for Excellence in Family Finding, Engagement, and Support.

Participation

A county may elect to participate in the EFFES Program by submitting a written plan to the California Department of Social Services (CDSS) by June 30, 2025, in accordance with instructions issued in <u>ACL No. 23-12</u>, and may begin accessing the one-time funds beginning in FY 2022-23 contingent upon notification from CDSS that the county's complete written plan has been approved.

Counties and Tribes that elect to participate in the Program will be able to access funding beginning in FY 2022-23. Counties and Tribes who choose to participate in the Program must opt in by June 30, 2025. After June 30, 2025, allocations from those counties and Tribes that did not opt-in by June 30, 2025, will be allocated to counties and Tribes that did opt-in in order to maximize funding. All funds must be expended by June 30, 2027.

The EFFES Program funding must be used for specialized permanency services and supports that augment existing funding. Funds may not supplant funds for existing family finding and engagement programs; however, counties may use funds to expand their existing programs. Please refer to <u>ACL No. 23-12</u> for further information regarding allowable activities.

County Match

Counties will need to demonstrate a 50 percent match of local funds, which may include in-kind contributions of services or other resources from the county or community-based organizations to the state funds being offered through the program. Funding

The attachment displays the planning one-time allocations for all counties assuming all counties choose to participate in the EFFES Program. A final distribution will be provided in a forthcoming allocation CFL after the June 30, 2025, opt-in deadline mentioned above.

CWDs

In consultation with the County Welfare Directors Association of California, approximately \$138.0 million GF is distributed to CWDs based on each county's percentage of the total statewide number of child welfare agency foster care placements, ages 0 through 18 years, excluding pre-adoption, dependent and non-dependent guardian, and trial home visit placements, during federal FY 2022, taken from the Child Welfare Services/Case Management System (CWS/CMS). A minimum floor adjustment ensures each CWD receives at least \$48,000 GF.

CPDs

Approximately \$4.4 million GF is distributed to CPDs based on each county's percentage of the total statewide average number of probation department foster care placements, ages 0 through 18 years, excluding pre-adoption, dependent and non-dependent guardian, and trial home visit placements, during federal FYs 2020 through 2022, taken from the CWS/CMS. A minimum floor adjustment ensures each CPD receives \$27,782.

Claiming

Detailed claiming information will be provided in a forthcoming claiming CFL.

As stated in <u>CFL No. 14/15-29</u>, CWDs may submit allowable claims on behalf of CPDs. CWDs and CPDs should reference the developed Memorandum of Understanding that designates roles and responsibilities between the two agencies related to pass-through funds and claim submission for reimbursement for further information. CWDs and CPDs may, and are encouraged to, collaborate in the EFFES Program.

Closeout

After June 30, 2027, any unspent funds that have been allocated to participating counties and Tribes via the forthcoming final allocation CFL will be redistributed to participating counties and Tribes during the year-end closeout process to maximize the funding.
